Sub:- Extension of dateline for online validation of applications of e-Medhabruti for the year 2016-17 (Fresh) in respect of colleges of PG, Technical and Professional Colleges.

(2) Extension of dateline for online validation of records under all categories of renewal (Jr. Merit / Senior Merit / P.G / Technical & Professional).

Madam/Sir,

I am directed to invite a reference to the above subject and to say that as there are good number of requests from different Institutions for extension of dateline for fresh and renewal applications for the year 2016-17 and 2017-18 , the following datelines have been extended.

(1) The dateline for online authentication /validation at the level of Principal / Head of the Institution of concerned colleges for e-Medhabruti to PG, Professional & Technical courses for the year 2016-17 (Fresh) is hereby extended up to 30th November, 2017.

The extension of date for online submission of the applications for the 2017-18 (Fresh) by students of Technical / Professional and PG and the authentication of applications by the concerned Heads of Institutions has already been extended up to 20th November, 2017 and 30th November respectively vide this Department letter No. 27451/HE dated 20.10.2017.

(2) Similarly, the dateline for online authentication by the Principals/Head of the Institution of concerned colleges for e-Medhabruti to all categories (Jr. Merit / Senior Merit / PG, Professional & Technical) for the year 2016-17 (Renewal) and 2017-18 (Renewal) in respect of all SAMS and Non-SAMS Colleges is hereby extended up to 30th November, 2017.

(3) The records of students who have done their last year in 2016-17 (like PG in15-16 Selection) & Technical /Professional (different years depending on the course) and have already left the institutions can be validated without uploading of records like Mark sheet, Residence certificate, Income Certificate etc. The relaxation on the uploading of documents in respect of final year students of +2 and +3 for the year 2016-17 (Renewal) as mentioned in this Department letter No. 28638/HE dated 28.10.2017 remains unaltered.

(4) Authentication for fresh selection for 2016-17 and 2017-18 under Jr. Merit and Senior Merit category is closed. Final list of selected students is being published shortly.

All Principals/Head of the Institution of SAMS & Non-SAMS colleges are hereby instructed to validate the records of students as per extended datelines.
