YEAR 2016-17 & 2017-18 IN RESPECT OF TECHNICAL &
PROFESSIONAL MERIT ONLY**

It is hereby informed to all Principals / Heads of Technical and Professional colleges/institutions in the State of Odisha and outside Odisha that there are certain un-validated data of students who have applied for e-medhabruti for the year 2016-17 and 2017-18 under the above Fresh category and due to non-validation by the concerned authorities of the colleges, institutions etc., some students are deprived of getting scholarship for whole duration of the course.

Now, Government have been pleased to activate the window for online validation of un-validated data of students pertaining to the year 2016-17 & 2017-18 who are continuing in the study as per the guidelines of the concerned years as a one-time measure.

The Principal's validation window for 2016-17 (Fresh) & 2017-18 (Fresh) shall remain open from 26.11.2018 to 26.12.2018.
